In 2020, economic development agencies assisted with 78 projects in the Valley that resulted in nearly \$3 billion dollars of new investment, 4,191 new jobs and the retention of 1,965 existing jobs.

The combined resources of these entities supported and assisted with infrastructure investment, tax incentives, loans, project coordination, grants oversight, technical advisement, property development and other services. Notable activity is highlighted.

# **Direct Business Development**

- Posted 562 staff-assisted job orders totaling \$134,880.
- Held 30 onsite recruitment events that were valued at \$15,400.
- Serviced 142 individuals with onthe-job training valued at \$636,687.
- Managed 105 Individual Training Accounts worth \$647,194.
- Helped 438 companies raise \$36.2 million in capital investment that resulted in 2,060 new and retained iobs.
- Assisted 12 companies as new business startups, including two startups with acquisition by investors.
- Issued bonds totaling \$30.6 million for two companies.
- Assisted 110 contract actions for companies to secure more than \$21.4 million in local, state and federal government contracts.
- Worked with 127 active clients to identify government funding opportunities.

- Attended 538 one-on-one business retention meetings.
- Held 52 business networking events and opportunities that reached 3,265 attendees.
- Responded to 55 business inquiries and requests for data or regulatory information.
- Increased new client intake five-fold and secured more than \$100 million in investment for clients.
- Provided 182 clients counseling totaling 715 hours in 727 sessions.
- Assisted minority, women and veteran-owned businesses in receiving 23 Ohio Minority Microenterprise Grants amounting to \$230,000 of direct capital infusion and creating a total impact of \$320,000.
- Helped eight businesses receive MBE certification and 10 businesses receive EDGE certification.

## Attraction/ Marketing Efforts

- Continued to work with leaders around the state and nation to build research, development and operations capacity at YARS and Camp James A. Garfield in Ravenna.
- Successfully advocated to protect four C-130J aircraft in the federal budget and positioned YARS as one of only two installations to receive the aircraft.
- Implemented marketing efforts that generated 43 leads from non-local entities and 13 visits to the area from companies.
- Attended the Consumer Electronics Showcase.

# **International Exports & Investment**

- Facilitated \$10.21 million in export sales growth throughout Ashtabula, Mahoning, Trumbull, Columbiana, Carroll, Stark, Holmes, Portage, Tuscarawas and Geauga counties.
- Enrolled 15 students in the Ohio Export Internship Program to complete summer internships with Ohio companies.
- Assisted export clients with shipments to more than 86 countries.
- Continued collaboration with OH-PA Export Initiative (OPEI), which leverages the region's export resources and supply chains to take advantage of international business opportunities.

#### **Real Estate Development**

- Approved 24 design/sign/demo applications.
- Received 23 inquiries regarding downtown buildings.
- Received three city properties to be redeveloped.
- Entered into leases with Ultium Cells for construction of new manufacturing facility in Lordstown and Washington Prime Group for redevelopment of former Sears retail store in Boardman.
- Received a \$1.7 million Federal Aviation Administration AIP grant for the Youngstown-Warren Regional Airport for a snow removal equipment facility and acquisition of snow removal equipment.

- Completed renovations on the 2nd floor of the former Harshman Building in Youngstown for Eastern Gateway Community College.
- Managed and completed contracts for environmental studies, engineering, demolition and new construction at the former Chemical Bank property in Boardman.
- Received \$10,000 Federal Highway Administration grant for CASTLO redevelopment project.
- Managed three construction projects totaling \$2,455,000 at the Youngstown-Warren Regional Airport.

- Assisted Mahoning County Board of Health with building acquisition.
- Maintained available building/site inventory with nearly 200 properties online.
- Created a pipeline of development projects aiming to utilize the Ohio
   Site Inventory Program.
- Completed more than \$2 million of necessary capital improvements at the Mahoning Valley Campus of Care, which will house specialneeds residents.

#### **Transportation & Infrastructure Development**

Between July 1, 2019 and June 30, 2020, approximately \$67.9 million in federal funds were obligated for 45 highway, transit and non-motorized projects in the Valley.




### Collaborations, Partnerships & Planning Development

- Attended 163 meetings involving development issues.
- Advocated for more than \$5 million of Valley projects to receive funding in the state capital budget and capital re-appropriations bill.
- Highlighted 52 in-demand occupations to assist jobseekers and employers.
- Published the Construction and Procurement Guide as a single source of information to spur business and real estate development in Mahoning and Trumbull counties.

- Promoted additive manufacturing supply chain deployment in the Valley.
- Received grants for two critical infrastructure projects totaling \$1 million in Trumbull County.
- Established a Community
   Reinvestment Area in the Village of Newton Falls.
- Received \$444,150 in grant funds for the Youngstown Air Reserve Station (YARS) Joint Land Use Study (JLUS) implementation.
- Utilized a \$750,000 Neighborhood Revitalization Grant for street and sidewalk improvements, flood and drainage upgrades and park enhancements in Masury.
- Led local cohort in the Forward Cities Learning Collaborative, focused on strengthening our local equitable entrepreneurial ecosystem.
- Conducted citywide U.S. EPA petroleum brownfield assessment, including 12 Phase I and Phase II environmental assessments, two universal waste surveys and two remedial/clean-up plans.

# COVID-19 Response

The entire world was disrupted by the COVID-19 pandemic in 2020. In an effort to contain the rapidly spreading virus, a near-total shutdown of all businesses began in March, followed by residential movement restrictions. Only specific businesses, deemed by the government to be essential, were allowed to remain open to the public. The list included hospitals, primary medical care providers, manufacturers that produced personal protective equipment and those businesses that supported healthcare, first responders and other services.

Companies transitioned to a remote workforce, laid off employees or completely shut down, depending on their circumstances. Ohio-based companies gradually reopened to the public in late summer, provided they followed tiered guideline and social distancing requirements. At the start of the worldwide pandemic, information was sporadic and difficult for businesses to navigate. Local economic development providers in Mahoning and Trumbull counties united in communication, developed a strategy and provided direct assistance to our local employers. The following list shows the combined efforts of our local agencies to assist businesses with the COVID-19 crisis.

- Continued to provide workforce services by phone and internet.
- Processed 39 forgivable COVID-19 business support loans for Warren businesses, distributing \$118,463 to help with PPE and other related expenses.
- Partnered with the U.S. Small Business
   Administration (SBA) and hosted Facebook Live
   event assisting small businesses on how to apply
   for SBA programs.
- Conducted citywide restaurant and bar focus groups.
- Created and distributed a curated resource guide for businesses.
- Conducted an outreach campaign by surveying for business challenges and communicating available resources.
- Received \$69,000 CARES Act grant for assistance to offset loss in airport operating revenue.
- Held one safety webinar—COVID and the Workplace—reaching 57 attendees.
- Launched the EMERGE program to help Valley businesses successfully emerge from the COVID crisis, as well as the EMERGE Safely pledge, with more than 60 companies signing on to reopen safely by following state guidelines and protocols.
- Provided one-on-one assistance to local businesses to help navigate the opportunities and regulations resulting from the COVID crisis.
- Distributed more than 600 personal protective equipment tool kits.

- Maintained a clearinghouse of COVID information online, with links to appropriate local, state and federal resources.
- Continued outreach to businesses through virtual meetings/events, newsletters and social media.
- Received \$560,000 in CARES Act funds to support Economic Development Districts and commission a regional broadband feasibility study to support rural and urban centers with access and increased speed.
- Administered 120 loans in Paycheck Protection Program, Round 1, totaling \$2.3 million.
- Processed 474 CARES Act loans in Mahoning and Trumbull counties for nearly \$4.4 million, which resulted in the retention of 3,040 employees.
- Contracted with technology firm to create a "buy local" app in support of small businesses.
- Created and hosted COVID-19 Economic Development Task Force.
- Formed partnerships with Technical Assistance Providers and secured \$20,000 from KeyBank Business Boost & Build for the COVID-19 Business Stabilization Program.
- Advocated for passage of legislation that made it easier for businesses to receive Paycheck Protection Program loans, loan forgiveness, COVID-related grants and safeguards against frivolous COVID-related lawsuits.
- Created 50 new jobs and retained 65 jobs through direct outreach.

   with a total cost of \$13.6
   million in our tri-county district.
   Projects included infrastructure,
   workforce training/education
   and business development, all
   of which created 34 new jobs

   jobs.
- Employed nine undergraduate students and one graduate assistant in business and export projects.
- Hosted the annual D.C. Fly-In virtually to create awareness of area issues for state and federal government leaders.
- Brought on inaugural Venture for America Fellow.
